Mr L Gila	<p><b>FAIRVIEW RACECOURSE - RACE 4 - 04.02.2025</b></p> <p>Rule 73.2.3 – As the Trainer responsible for BRIGHT FUTURE when specimens, which were collected from this horse after the running of the abovementioned race on 4 February 2025 at Fairview Racecourse, disclosed upon analysis the presence of Flunixin (Class 4) which is a prohibited substance. Fined R25 000 and in terms of Rule 72.3.2 BRIGHT FUTURE was disqualified from the said race. Rule 67.7.8 applies.</p>
Mr L Gila	<p><b>FAIRVIEW RACECOURSE - RACE 4 - 04.02.2025</b></p> <p>Rule 10.5.14 – In that he failed to accurately record or cause to be accurately recorded, in a Treatment Register, veterinary treatment administered to the horse BRIGHT FUTURE under his care. Fined R2 500.</p>
Mr L W Karriem	<p><b>- 11.04.2025</b></p> <p>Rule 10.5.1 – As a Licensed Trainer, subject to the Rules of the NHA and responsible for the care, treatment and training of horses under his control, failed to provide a reasonable level of care and treatment to a number of horses in his care. These horses, upon examination, were found to be in poor condition and showed varying degrees of neglect. Penalty imposed: Trainers License cancelled.</p>
